**Terms and Conditions**

The Contest, which specifically includes any offers made in connection with the Contest, is offered to Eligible Participants to the following terms and conditions (the “**Terms**”). By participating in the Contest and taking advantage of Contest offers, you represent that you are Eligible and acknowledge and agree to be bound by these Terms.

**The Contest is not sponsored, endorsed, administered by, or associated with Instagram (“Instagram”) and Facebook (“Facebook”).**

**1. Contest**

- 1.1.** 16 August – 25 September 2021 (“**Contest Period**”)
- 1.2.** Contest applicable with online and in-store purchases during the Lucky Draw Period.
- 1.3.** Only valid for purchases of branded notebook or PC powered by AMD processor (A series - Ryzen series).
- 1.4.** Only valid for purchases from authorised AMD resellers only.

**2. Eligibility Requirements**

- 2.1.** This Contest is open to individuals who meet the criteria described below (the “**Eligible Participants**”):
- 2.2.** Open to all Malaysian citizens, residents, work permit holders, valid Malaysian pass holders, and is valid in Malaysia only.
- 2.3.** If you participate in the Contest, AMD reserves the right to contact you directly or through an appointed AMD vendor to verify that you are an Eligible Participant. AMD will have sole discretion to determine the sufficiency of any documentation that you provide to verify you are an Eligible Participant. By providing eligibility-related information to AMD’s appointed vendor, you agree that the vendor may share such information with AMD for Contest-related purposes.

**3. Campaign Mechanics**

- 3.1.** The following are four (4) steps for the Contest:  
Step 1: Purchase listed AMD products from the Participating Reseller(s).
